Program Expectations and Requirements

Program Course Work

At Kennedy-King students currently have access to the following certification and degrees:

- Basic Certificate (BC): CHLD DV 101, CD 107, CD 120, CD 149, CD 262
- Advanced Certificate (AC): CHLD DV 101, CD 107, CD 120, CD 149, CD 201, CD 262; English 101; one elective CHLD DV course of choice; one General Education course; and one Math or Science course
- Associate in Applied Science in Child Development: Pre-School Education (AAS):
 Students earn the BC and AC while completing the AAS. This is the best degree option for students planning to go straight into the field after completing their Associates degree.
- Associate of Arts (AA): Students earn the BC while completing their AA, this is
 the best option for students who are planning to transfer to a four-year degree
 institution.

Field Experiences

Students enrolled in Programs in the Child Development Program are required to complete field experience/Practicum hours.

Background Check/ Physical: All students enrolled in the Child Development Program are mandated to complete field experience/Practicum hours at a facility requiring a background check and/or health physical (TB test). Students must also complete field experience hours at a pre-approved facility on the site list. Students may also have the option to complete hours at a local public school with a Head Start Program. Background checks and health physicals are usually effective for one calendar year, and the cost of these requirements are primarily the student's responsibility. Please follow each individual's site requirements for the completion of background check and health physical requirements. If a student has an adverse background,

he or she must consider the impact of this factor on his or her completion of the Program, and/or future employment opportunities. Please consult with the Program Coordinator or course instructor if you have any additional questions.

Professionalism: All students enrolled in the Child Development Program are expected to adhere to casual professional attire while visiting school sites. Students should avoid overly exposed feet and skin, excessively fitted clothing, tattoos, etc. in an early learning environment. An example of casual professional attire is as follows: Khakis, polo shirts, corduroys, button-ups, and walking shoes.

Cellular Phone Use Policy: Students should not use cellular phones in the school sites, nor should cellular phones be visible during site visits. Students are expected to turn-off, or silence all cellular and electronic devices while in attendance in an early learning facility.

Disposition: As a future education professional, it is very important to enter the facility with a positive attitude, and willingness to learn. Cultivating relationships with school staff, and administrators will be integral to students being invited to continue field experiences at various school sites. As a result, it is necessary to maintain professionalism in groom, dress, and during interpersonal communication. Early Childhood Education is a very collaborative, service, and people-oriented profession, which will require students to engage respectfully and effectively with fellow peers, teachers, professors, staff, and children. Practicum

All students seeking enrollment in Practicum must complete the 9 (CHLD DV 101, 107, 109, 120, 143, 149, 201, 258, 262) prerequisite courses prior to enrolling. Practicum candidates must also complete an application. Applications for students seeking enrollment in a spring practicum must be submitted no later than the last Monday in the month of November. Students seeking enrollment for the fall semester must apply no later than the last Monday in the month of March. Students are also required to attend a mandatory orientation before enrolling in the class. Failure to attend orientation will prevent students from registering for the course.

All students participating in a Practicum/field experience will be required to complete the following:

 Background Check (Please follow the facility's guidelines. The background check is usually valid for at least on calendar year.)

- Physical/ TB Test. (The health physical is usually valid for at least one calendar year.)
- The assigned Program Coordinator, Practicum Supervisor, Chairperson's signature is required for enrollment in the Practicum course.
- The Chairperson's and/or Program Coordinator's signature and approval is required to enroll in any courses concurrently.
- If a student is enrolling in a Practicum course, he or she must establish residency.
 The last 15 credit hours of the core coursework must be completed in the Child
 Development Program, prior to enrollment in any advanced courses.
- All course and program guidelines will be reviewed by course instructors at the start of each semester.

Dispositions/Professionalism

- Act in a mature, ethical, and informed manner in regard to relationships with fellow classmates, children, staff and parents. Strictly maintain confidentiality of records, meetings and conferences.
- Maintain professional attire throughout the field and or Practicum experience.

Frequently Asked Questions

- What credentials are available to students (BC, AC, and AAS) and are they stackable? At which campus is each credential offered?
 The Basic Certificate (BC) and Advanced Certificate (AC) in Child Development Pre-School Education are stackable into the Associate in Applied Science (AAS) degree. The BC is stacked into the Associate in Arts degree. The BC, AC, and AAS are available at all campuses except Wright College.
- Who is the contact person when students need advising?
 Contact your course instructor, and/or Program Coordinator if there are specific questions about the Child Development Program. Make an appointment with your

assigned advisor if you are seeking a degree to ensure you have all general education, and elective requirements complete in anticipation of graduation.

- Are there any new developments coming in the future?
 Kennedy-King College has added the Infant and Toddler Advanced Certificate Program.
- Is there anything else we should know about the program?

 The Kennedy-King Child Development Program is aligned to the state credentialing system called Gateways. The Basic Certificate (BC) helps students earn a Level 2 credential, the Advanced Certificate (AC) is Level 3 credential, and the Associate of Applied Science (A.A.S.) is a Level 4 credential. The Associate of Arts (AA) is a Level 2 because it has the BC stacked into the degree. Students who aspire to enter the workforce after finishing an Associate's degree, should complete the Level 4 credential, which will offer better options for employment. For students who want to transfer and earn a Bachelor's degree, the recommendation is an Associate of Arts (AA) degree because it transfers more seamlessly.
- Can having a criminal background prevent me from completing the Child Development: Pre-School Education Program? Not all backgrounds will prohibit students from obtaining a credential in the ECE field. However, students will need investigate the impact of their individual backgrounds on their employment chances in the field.

Application and Cohort Information

- Is there a minimum age requirement to participate in the program?
 It is not explicitly stated, but students must meet the requirements of the college and labor laws to be employed.
- Do students need to have previously completed high school or their GED?

 Students need to complete high school, or a GED to earn a Level 1 Gateways Credential.
- Are there any prerequisites for the program, including English level and/or GPA?
 To take CHLD DEV 101, students must be eligible for English 101. However, there are 3
 CHLD DEV courses students can take prior to earning English 101 eligibility and those 3
 courses (CHLD DV 120, 107, and 149) are included in the BC (5 courses total).
- Is there an application deadline/period, or a time when the program starts?
 - If yes, what is the application process? No, there is not currently an application process. In general, students can begin taking courses during the fall, summer, or spring semesters.

Course-Specific Information

- Are the semester maps and course catalogs updated with your department's preferred course selection and sequence? Yes, the catalog and semester maps are updated regularly.
- How often are the core/required courses offered? Are they offered at multiple campuses? The core courses are offered at all campuses (except Wright College), usually multiple sections of each course are available.
- All of the core courses must be complete before students who are seeking an Associate
 in Applied Science (A.A.S) can enroll in the Practicum course. Students must complete all
 core course requirements with a grade of "C" or better. The following courses must be
 completed: CHLD DV 101, 107, 109, 120, 143, 149, 201, 258, 262
